## THE CIVIL LAW NEGOTIATION COMPETITION



The Civil Law Negotiation Competition focuses on an area of law that raises issues of equity, diversity and inclusion. Participating teams negotiate conflicts based on current issues affecting the Canadian community. The competition simulates legal negotiations in which law students, acting as lawyers, negotiate a series of legal issues. The competition is open to all law students, but each team must include at least one black or visible minority student.

Our competition aims to develop students' negotiation and advocacy skills, enabling them to transfer what they learn into their future practice. We want students to learn to express their points of view, access information and explore various choices and options, in order to find winning solutions to the problems presented to them. The Civil Negotiations Competition offers students a unique opportunity to develop practical skills while learning about important social issues. BLSA Canada hopes that students will come away from their competition experience enriched in knowledge and seeking to become agents of change for the future.

The competition will take place from January 26 to 27, 2024 in Ottawa. This year's field of law is technology law. All our chapter members in the various civil law faculties have expressed interest in participating in this second edition of the competition. We would like to thank the University of Ottawa's Faculty of Law and Blake, Cassels & Graydon LLP for their support in organizing the competition.
