

# WE HOSTED OUR LARGEST EVER CONFERENCE

#### **BOLSTERING CHAPTER FUND**

BLSA Canada recently bolstered its Chapter Fund model, an initiative designed to provide financial support to BLSA chapters nationwide, by developing a disbursement model to ensure that funding is distributed equitably and transparently based on the needs of each chapter. The Chapter Fund has already provided nearly \$13,000 in funding to chapters in various cities, enabling them to host events, participate in conferences, and engage with local communities. This initiative is a testament to BLSA Canada's commitment to supporting the development and growth of its chapters, and to promoting community and solidarity on a grassroots level.

#### **GOVERNMENT CONSULTATION**

This year, BLSA Canada was actively involved in the federal government's pre-budget consultations, where we advocated for issues affecting Black law students and the wider Black community. BLSA Canada's pre-budget submission called for increased investment in the education and training of Black lawyers and law students, as well as support for programs and initiatives that address systemic racism and promote diversity, equity, and inclusion in the legal profession. BLSA Canada also spoke with the Department of Justice on its Black Criminal Justice Strategy and our advocacy efforts highlight the need for meaningful action to address the ongoing barriers faced by Black Canadians.

#### **CENSUS REPORT**

The BLSA Canada Black Law Student Census Report is novel research project that examines the experiences and challenges faced by Black law students in Canada. The report provides valuable data on issues such as representation, equity, and inclusivity within Canadian law schools. BLSA Canada aims to conduct this research project every few years to track progress and identify areas for improvement. The report is a critical resource for Canadian law schools, policymakers, and stakeholders who are dedicated to advancing diversity, equity, and inclusion in the legal profession.







### THE BLSA Impact



At BLSA Canada, we are committed to empowering change by providing resources that create sustainable impact both domestically and internationally. Our programs, such as the National Conference and the Chapter Fund, offer valuable resources and support to help students succeed and make a positive impact in their communities. Nationally, our mentorship program provides critical support in the form of mentorship to help Black Law Students thrive in their careers. By providing these resources and programs, we are working to create a more equitable and just legal profession for future generation of lawyers.

On average, only 4 per cent of contributions go toward administrative costs. Having such a low administrative rate means we are able to focus on creating sustainable change where it matters most.

BLSA Canada's national scope allows us to focus on breaking the cycle of systemic barriers that have historically burdened Black law students and lawyers. We seek to develop communities through holistic, sustainable solutions and advocacy.

In law schools across Canada, BLSA Canada works to engage hundreds of Black law students through programming that focuses on developing the students of today into future change-makers and leaders in the legal profession.

We want to provide every Black law student with the resources and skills not just to change their own lives, but to positively affect the lives of others in their communities—at home and across Canada. By providing Black law students with opportunities and tools for success, we help empower them to further educate, advocate and innovate to solve the issues facing our world.

### Pillars of *Impact*

### Mentorship

Mentorship plays a crucial role in ensuring the success of Black law students. It is incumbent upon all of us to assume the role of a mentor and assist those who are striving to catch up with us. Through the BLSA Canada mentorship program, we are able to provide professional support law students and legal professionals from Black and other underrepresented communities. Our mentorship program is designed to provide mentorship, quidance, and support to Black law students across Canada.



By the end of 2023, BLSA Canada will have matched more than 150 Black law students with mentors.



#### Community

As Black law students pursue their education, they equip themselves with the knowledge, confidence, and determination to advance their careers, uplift their communities, and inspire future generations. In addition to providing resources for legal education, we offer support by providing a vibrant community and network. This allows for career development. mentorship, and extracurricular activities that foster a sense of community and well-being. This comprehensive approach ensures that Black Law Students are equipped to succeed in their studies and future legal careers.



In 2023, we hosted a number of community events including are largest conference ever which saw more than 500+ attendees from across Canada and the United States.





### Experience

Access to practical legal experience through internships, externships, and other opportunities can help Black law students build their skills, confidence, and networks. Practical experience can also help students identify their interests and goals within the legal profession. BLSA Canada is proud to host several student competitions that will help students stand out in this competitive job market.



In 2023, BLSA Canada submitted a proposal to the federal government for a wage subsidy that will allow us to hire two summer research students.



### Support

Black law students face systemic barriers and discrimination that can affect their academic and professional success. Access to academic, financial, and emotional support can help students navigate these challenges and overcome obstacles to achieve their goals.



In 2023, BLSA Canada Partnered with BMO to distribute \$10,000 in scholarships to Black Law Students across the country.


Our fundraising model reflects our vision for sustainable development and empowering Black law students across Canada


### CIVIL LAW SYMPOSIUM

The 2023 BLSA Canada Civil Law Symposium was a resounding success, bringing together the most attendees in its history. ### Julius Alexander Isaac *Moot*

#### Canada's only student-run for credit law school Moot

The moot is named after the first Black person to sit on the Federal Court of Canada and a trailblazer in the legal profession: Justice Julius Alexander Isaac. The Moot brings together students from across Canada to compete in a simulated court case related to Critical Race Theory. The 2023 Julius Alexander Isaac Moot was our most successful moot to date, with 44 students competing from 12 law schools across Canada. The moot drew the attention of more than 150 attendees, including lawyers and judges. BLSA Canada was honoured to have the Honourable Mahmud Jamal (Justice of the Supreme Court of Canada) as a final-round moot judge.











Black law students who face unique challenges in the legal profession. By competing against their peers from across Canada, participants have the chance to showcase their talents and gain valuable experience that will serve them throughout their legal careers. Participating in the moot is not only a way to develop legal skills, but it is also a way to honor the legacy of Julius Alexander Isaac.

### National Conference

#### We made history together...

The Black Law Students' Association of Canada (BLSA Canada) hosted its largest-ever conference this year, drawing over 500 attendees nationwide. The conference provided a unique opportunity for Black law students and legal professionals to network and learn about critical issues impacting Black communities in Canada. One of the event's highlights was a bus tour of North Preston and Africville, which gave attendees a chance to learn about the vibrant African Nova Scotia history.

North Preston is a historically Black community just outside Halifax, Nova Scotia. It is one of the oldest Black settlements in Canada and has a rich cultural history that spans generations. The tour took participants through the community, stopping at significant locations such as the historic St. Thomas Baptist Church and the North Preston Community Centre. In addition, attendees had the chance to learn about the community's history and culture from local residents who shared their personal stories and experiences.

Africville, located on the outskirts of Halifax, was once a thriving Black community before it was demolished in the 1960s as part of an urban renewal project. The tour included a stop at the Africville Museum, which preserves the history and legacy of the community. Attendees learned about Africville's vibrant past, including its history as a thriving seaport and the struggles its residents faced when their homes were forcibly taken away.

The bus tour gave attendees a unique opportunity to learn about African Nova Scotia history and the contributions of Black communities in Canada. As well, it allowed participants to engage with local residents and gain a deeper understanding of the issues affecting Black communities in the area, including racism, poverty, and systemic discrimination.

In addition to the bus tour, the BLSA Canada conference featured a range of panels, workshops, and keynote speeches that explored issues facing Black legal professionals and our communities. Attendees heard from prominent speakers, including lawyers, judges, community members and policymakers, who shared their perspectives, experiences and advice.

The conference also provided a platform for law students to network and connect with legal professionals nationwide. Attendees had the opportunity to attend career fairs, participate in mock interviews, and meet with representatives from top law firms and legal organizations.

Overall, the BLSA Canada conference was a tremendous success, bringing together a diverse group of legal professionals and students to learn, network, and engage with critical issues related to our theme of justice. The bus tour of North Preston and Africville was a powerful reminder of the importance of preserving and celebrating African Nova Scotia history, and the role that the legal profession can play in advancing social justice and equity.

#### The Model

The BLSA Canada Chapter Fund establishes a mandatory minimum approved amount for each chapter, which remains consistent across all BLSA Canada chapters. This designated minimum amount is accessible to all chapters without any financial assessment criteria.

Eligibility for funds beyond the designated minimum amount is calculated using two multipliers. The first multiplier is based on chapter size in relation to the total nationwide membership of BLSA Canada. For instance, if a chapter comprises 100 students and the nationwide membership is 1000, the multiplier will be calculated based on the percentage

he chapter's membership accounts for relative to the total membership. Chapters with a higher percentage will receive a higher multiplier. The second multiplier is based on financial need, with chapters ranked relative to each other. Chapters with a financial surplus or no need will not qualify for this multiplier; however, larger chapters will still benefit from the first multiplier based on chapter size.

The BMO Scholarship saw the highest number of applications, receiving 34 from Black law students across Canada

BMO and BLSA Canada partnered to grant four scholarships, worth \$2,500 each, to Black law students in their second, third, or final year of law school in a recognized JD/BCL/LLB/LLL law program. BMO and BLSA Canada recognize that the cost of law school and articling is prohibitive to many racialized students. The BMO-BLSA Canada Scholarships reduce the financial burden of a legal education and licensing costs. In addition to financial support, BMO-BLSA Scholarship recipients have the opportunity to be mentored by BMO lawyers and attend select BMO events and workshops. Scholarship recipients were announced at the 32nd Annual BLSA Canada Conference.







### BLSA Canada Partners

This year, BLSA Canada has expanded its partnership program by welcoming four new law firms to its fold: Baker Mckenzie, Norton Rose Fulbright, Dentons, and Gowling WLG. This is a testament to BLSA Canada's growing influence and impact on the legal profession in Canada.
